Calls for Expressions of Interest for the development of this 5,893m² site, in partnership with the landowner, has been advertised. The site is located in a prime position, complemented by the impressive St Leonards Catholic Church which will continue in operation and remain the prominent feature under any redevelopment scenario. This property is in close proximity to the local Naremburn shops as well as the buzzing cafes and shops of Crows Nest Village.

Church parishioners expressed a clear desire to protect and enhance the curtilage of the heritage listed St Leonard's Church. The need to continue to maintain it and ensure as the result of any potential development that newly developed Parish hall and parish facilities would be provided along with adequate car parking and additional income to sustain the parish well into the future.

Two development scenarios would be considered: retaining CatholicCare on the current presbytery site as an adaptive reuse development option; and a development option that does not include a parish use (ie CatholicCare), also an adaptive reuse option.

Bus service changes will occur to the Lower North Shore in December, most of them impacting Mosman to Northern Beaches, and some affecting the Willoughby area, notably:

Route 257 Chatswood to Balmoral will be scrapped. Commuters will have to catch the 343 to Crows Nest and connect to new Route 114. Crows Nest to Balmoral Beach.

Route 143 Manly to Chatswood via St Leonards and 144 Manly to Chatswood via Royal North Shore Hospital will be replaced by a new Route 144 from Manly to Chatswood via St Leonards. This service will operate via the Pacific Highway, with stops for Royal North Shore Hospital near Reserve Road.

Route 136 Chatswood to Dee Why service will be withdrawn and replaced by a frequent service 160x Chatswood to Dee Why via Frenchs Forest (limited stops).

The local property market has been performing better than expected with many record sales and strong buyer competition. A recent Financial Review article mentioned that while many Australian property markets are still reeling from the effects COVID, sales across the lower north shore have continued steadily.

In September and October my team and I successfully negotiated the sale of 32 properties across the lower north shore, 18 of which were in Naremburn alone. Some standout results include the sale of 51 Park Road, 9 Probate Street, 56 Northcote Street and 303 Claire Street, all of which sold prior to auction for \$3,350,000, \$3,105,000, \$2,950,000 and \$2,740,000 respectively.

The townhouse and apartment market has also been performing well, with recent sales including 27/55 Garland Road and 3/36a Park Road, both selling prior to auction for \$2,100,000 and \$1,395,000. We also had some great results off-market with the sale of a 44 Darvall Street, a two-bedroom, single-fronted home, which sold to a buyer on our database for \$2,210,000.

While many buyers are looking for property, available real estate is missing. There simply isn't a lot of stock available and this is creating strong competition for quality properties that do come on the market. Increasing this demand is the numerous buyers looking to secure a purchase before Christmas, with a 2021 settlement.

WHAT'S HAPPENING AT CHANNEL 9



Mirvac's planning is moving right along and a start on site is expected by the end of this year. Channel 9 has already started to move out and by the end of November should be substantially off the site. Work started around mid-November with site establishment followed by commencement of demolition on the main site. It is anticipated that early next year work will start on the demolition of the TV tower. It is likely the tower demolition will be done using a very large tower crane alongside the TV tower. The DA for demolition work has been approved as has the modification of the Concept Plan to include the removal of the TV tower and the addition of building K in its place. The DA for building K will be submitted in October and will result in a total of 441 apartments over the whole site.

With the approval of the demolition plan it is assumed that Council has accepted Mirvac's Traffic Consultant's study showing that for heavy trucks coming to the site during the morning peak period, they will head south along Alpha Rd, Flat Rock Drive and Brook St before turning right into Merrenburn Ave and then turning right into Willoughby Rd. Mirvac states an average of 8 and a maximum of 14 heavy trucks per day can be expected to use this route during the demolition phase of the project though less during the morning peak period.

Hours of work on site will be 7am to 5pm Monday through Friday and 7am to 3pm Saturdays. It is envisaged work will shut down over Christmas between December 24 and January 4.

Request for Extension on WHT Submission



North Shore schools and community groups wrote to the Premier and Felicity Wilson to request a suspension and re-exhibition of the Western Harbour Tunnel (WHT) and Warringah Freeway projects post COVID-19.

Several community groups, Progress Associations and Precinct joined to support this, escalating the request to the Planning Minister after the Premier said she is not responsible for the decision.

With COVID restrictions, families have been unhtiable to engage with the project or read the 9,000-page technical document, which prevented them from making an effective submission. Any submission received would thus show just a small view of the widespread community dismay.

This caused concern, as the Environmental Impact Statement (EIS) is distressing. Effects include soil contamination at the Rosalind Street site, contamination of Flat Rock Creek, increased upstream traffic due to expressway changes, air and noise pollution – requiring noise attenuation on homes, and a safety hazard to children during works.

One statement from the Mayoral Minutes said, "In its current form, this project trashes our open space, undermines our economic and sustainable future and may jeopardise the health of our residents. I don't believe I am going too far when I say that this project will leave a trail of devastation."

At the time of going to press it appears our submissions for suspension and re-exhibition were unsuccessful and both projects are going ahead.

Tribute to Trisha Fitzpatrick



It is with sadness that we note the recent passing of a long term stalwart of the Naremburn Progress Association (NPA), Trisha Fitzpatrick, who passed away on 4th September 2020, aged 81 years. She is survived by her husband, Kevin, and two daughters Carolyn and Melissa.

Trisha provided a very strong contribution to the NPA, as she was part of the committee that launched our newsletter, Naremburn Matters, and was its editor for a number of years. She also filled the role of Public Officer with distinction for many years, drawing on experience gained in corporate life. With Kevin, she was instrumental in setting up the NPA Records Room within our local Community Centre.

With a keen sense of humour mixed with an unshakeable belief in what she saw as right or wrong, Trisha was a very strong advocate for local services such as branch libraries and other community centre services, and was determined to get the best result for Naremburn residents and businesses.

Both the Willoughby City Council Mayor, Cr Gail Giles-Gidney and Naremburn Progress Association President, Roger Promnitz, attended Trisha's funeral on 18th September in recognition of Trisha's contribution, with the church bells ringing 81 times to celebrate her life.

LOCAL RABBITOH RISES TO HIGH OFFICE

Naremburn was the first village on Sydney's Lower North Shore, known originally as Central Township, then Dog Town and Pension Town.

It produced several characters. There was 'Frontend Phil' aka 'Aeroplane' because of his ample girth and habit of extending his arms for balance when he'd had one too many. There was also William Mathers Jack aka 'Silent Billy', a Scottish immigrant and local businessman who represented the area as Federal Member.

Billy opened a grocery shop in Walker Street, North Sydney in 1914 and purchased a horse and cart to sell butter, eggs, ice and freshly trapped rabbits. He married Annie Smith and settled in Pine Street, Cammeray before moving to Holtermannn Street, Crows Nest and later 35 Merrenburn Avenue, now The White Rabbit Childcare Centre.

During the Great Depression our suburb had its share of battlers and Billy had a heart for those in need. Families never forgot his kindness.

His community service started on the NPA. He was then elected Alderman for the Naremburn Ward in 1939, then Deputy Mayor in 1947. Later, he was elected Mayor for 1949 to 1950.

At the local level Billy, his wife and daughter Ella worked tireless to establish the Naremburn Amenities Development Association (the present-day Community Centre) in Central Street.

Billy was elected to Federal Parliament in 1949 with a modest majority of 750 votes but continually increased this margin until he retired from Parliament in 1966. He was also known for his silence here, although one of his Billy's speeches commenced, "I can contain my silence no longer."

Billy received the OBE in 1968 for service to Parliament and the community. On his death he was remembered as the local Rabbitoh who rose to high office and was given the final tribute, "he lived respected and died regretted."

As the Bush Regenerator and Team Leader for Flat Rock Gully, with Willoughby City Council, we have sought expressions of interest for a bushcare team along the Southern (Naremburn) side of the Bicentennial Pathway in 1997, which is the southern ledge of Flat Rock Gully.

This area has been devastated over the years. Most of the trees were taken, predators wiped out the native animals, a tip buried the waterfall, and market garden eventually filled the entire gully from Willoughby Road before it was stopped, mainly by the work of the Progress Association.

Help was needed and an enthusiastic bunch of locals turned up and began work in 1998. The tunnel under the Drive was completely cleared, weed matted, munched then planted.

Other large areas were done this way as we moved towards Henry Lawson Cave, which needed weeding as there were many original plants still there. Much of this area was lost to developments later on.

The group absorbed another smaller team from Nyree, now called 55 and work continued above the Cave as well and along to Gaza Road. We now meet once a month while the rest of Bicentennial



to Willoughby Road is maintained by the Regen Team.

With training, imagination and hard work, the Bushcare Team has created a diverse and beautiful area. Poetry events at Henry's Cave fit in well and most of the birds and other local wildlife have returned.

COVID Restrictions Fuel Possible Rat Plague

COVID-19 restrictions and the closing of many Sydney restaurants and offices could be causing a rat plague in the suburbs, experts say.

With many Sydney food outlets and offices closed, food waste has lessened and city rats have moved into the suburbs in search of food. Andrew Adler, owner of Pestworks pest control service, has noticed an increase in business.

"Some of my customers have reported seeing rodents on their property when they haven't had this issue in the past," Adler says. "The more densely populated suburbs now have 'rat runs'", he says – essentially highways in which rats travel.

Naremburn and Chatswood are said to be receiving migrating rats. Willoughby Councillor Lynne Saville says she has received an increase in rat sightings from residents, particularly around Chatswood CBD and parks in neighbouring suburbs.

Numbers are predicted to increase even more as COVID restrictions ease and suburban restaurants reopen. The increase in food waste is predicted to create a spike in breeding.

"Rats are prolific breeders," says Dr Grainne Cleary of the University of NSW. Female rats can give birth to 70 new rats every year. Experts estimate Sydney currently has a population numbering more than 500 million. Sam [last name withheld] from Crossfire Pest Solutions, however, is not convinced by the claims of numbers rising.

"With COVID, people are home more, so they are noticing more pests in general," he says.

This doesn't explain the increased sightings in parks though, says Councillor Saville.

Black rats are known to carry Lung Worm, a parasite that can be fatal to humans, Hantavirus and Tularemia, which attacks the skin, lungs and eyes. Vets in Chatswood and Crows Nest have recommended vaccinating pets for Leptospirosis while rats are on the move.

"I've seen black rats out during the day, and they are meant to be nocturnal," Dr Cleary says. "This shows they are in really high densities."

QUICK CHRISTMAS CHOCOLATE PANFORTE

This cheat's version of the classic Italian sweet uses ready-made fruit mince and wraps up nicely for Christmas.



INGREDIENTS

- 110g caster sugar
- 175g honey
- 50g unsalted butter
- 300g fruit mince
- 250g plain flour
- 100g cocoa powder
- 1 tsp grd cinnamon
- 1 tsp mixed spice
- Grated zest of l orange
- 100geach roasted hazelnuts, slivered pistachios and macadamias
- 1/2 cup (100g) chopped dried figs
- Icing sugar, to dust

METHOD

Preheat oven to 160°C and line an 18cm x 28cm lamington pan with baking paper.

Stir sugar, honey, butter and mince in a pan over low heat for 3-5 minutes until sugar dissolves. Sift flour, cocoa and spices into a large bowl. Add zest, nuts, figs, mince mixture and a pinch of salt. Stir to combine well – it'll be quite stiff. Tip into the prepared pan and use wet hands to press the top all over until smooth.

Bake for 15-18 minutes until firm on top. Cool in pan, then invert onto a board and dust with icing sugar. Cut lengthways into 5 thin sections, then cut widthways into 8 sections to form about forty 3cm squares.

Keep for up to 1 month in an airtight container in the fridge, then pack into muslin gift bags or cellophane. Makes 40.
