

INAUGURAL TASTES OF NAREMBURN

Hundreds of local residents come together to celebrate and support local businesses.

Local food, drink, live music and a healthy dose of spring sunshine set the scene for the Naremburn Progress Association's exciting spring event, the Tastes of Naremburn. The real highlight event, held on 18 September, was the way the Naremburn community came together to connect, socialise and celebrate.

Over several hours on a sunny Sunday afternoon, more than 1000 people visited the event; with toddlers, mums and dads, grandparents and every age in between enjoying excellent food and drinks from Naremburn businesses, local musicians, face painting and even a jumping castle.

Emanating from an idea only proposed by NPA vice president Matthew Smythe in early August, the Tastes of Naremburn developed into a whirlwind of activity in just a few weeks with some terrific support from Willoughby City Council, even becoming part of its exciting Emerge Festival. The Taste of Naremburn was a sharp learning curve for the NPA executive committee members (all local residents who volunteer their time to help make Naremburn even better).

All in all there were 16 different stalls allocated free to local businesses, and featuring the absolute best of Naremburn local products, services, treats, drinks and food along with three musical performances.

It was an incredible buzz on the day, with local residents and businesses asking at the end if we could put it on every weekend.

It all proved worthwhile in so many ways. Every shopkeeper interviewed said it was the most successful trading day they had enjoyed in years, and The Naremburn Progress Association signed up about 35 new members on the day.

NPA President Larissa Penn & vice president Matthew Smythe both said they loved creating an opportunity for local shops and home businesses here in Naremburn, to showcase how amazing our local businesses are. Matthew said, "We have such a vibrant community in Naremburn, and it was special to see our wonderful neighbourhood all together."

The NPA plans to make the Tastes of Naremburn an annual event to welcome spring each year.







As always, Naremburn is where the action is! The Tastes of Naremburn event was a huge success, and I would like to thank our wonderful team and

Willoughby Council for their support. We continue to give feedback to local decision makers regarding an array of issues via submissions and attendance at meetings/planning sessions:

- Council Meetings and Advisory Committees – the NPA advocated for the public forum and to reinstate previous committees, with independence and full scope. We have asked that the Bicentennial Reserve and Flat Rock Gully Advisory Committee continue with all projects included in scope given the compounding pressures on this area.

- Complying Developments the NPA challenged decision makers to take a more proactive approach. Fair Trading, DPIE and surrounding councils confirmed that councils can intervene.
- Local Environmental Plans / Development Control Plans – we requested that Naremburn's character and shop frontages be protected as new planning criteria comes into force – the outcome will be tabled at the December Council meeting.
- Henry Lawson's Cave the NPA lobbied for the protection of this important piece of social history. Council has committed to include it in their next review.
- Flat Rock Gully continued advocacy for the protection of this area, the containment of the tip and banning of synthetic grass.
- Donnelly Rd Development we presented to the planning panel which denied this DA however the owners have

now escalated this development to Land and Environment Court

- Streescape Design - we followed up with Willoughby Council to ensure prompt public exhibition. Public consultation is now open till 23 December.

Naremburn property set for a strong summer

As we wind down to the end of the year, the Naremburn real estate market shows no signs of stopping. Team Chauncy has had some outstanding results over the last few weeks, including several houses that sold prior to auction. These include 69 Brook Street selling for \$2,595,000, 95 Christie Street selling for \$2,850,000 after being on the market for only 8 days, 5 Dalleys Road selling for \$2,975,000 and 40 Darvall Street selling for \$3,108,000.

A number of our vendors are finding that selling off-market to buyers in our database has been an effective way to achieve their property goals. Some notable off-market sales include 5 Apex Street setting a new street record selling for circa \$3,600,000 and 14/20 Dalleys Road selling for \$1,155,000.

We have started to see a trend towards sales campaigns ending later in 2022 and starting earlier in 2023. It is no longer uncommon for inspections and auctions to start well before Australia Day and the return to school with many active buyers who continue to search during the Christmas / New Year break.

Peter and the team also continue to play an active role in the Naremburn community. The team attended the Trivia Night Fundraiser for Willoughby Community Pre-school. It was a fantastic night and our Auctioneer Zak Morcillo auctioned off the children's artwork. Just under \$10,000 was raised with all proceeds going towards supporting the inclusion of children with special needs.

Willoughby Leisure Centre

The rush to upgrade raises concerns about community safety

With ageing concrete, pumps and filtration there is no doubt Willoughby Leisure Centre needs an upgrade. Like many in the community, we are excited to see the new centre open in 18 months.

That said, the NPA has concerns about community safety associated with the works, as well as questions about the timing of the construction which will leave the community without facilities over two summers.

The pool site sits atop an old landfill area. Testing so far has found high chromium and other heavy metal concentrations in the area. Asbestos and other carcinogenic compounds

are additional concerns given the tip's history. Willoughby City Council has confirmed the tip is "declared as 'significantly contaminated', (and) is regulated under the Contaminated Land Management Act 1997 (CLM Act)." Council has also confirmed that "The current status ...(of) the WLC site, is "under assessment", and is on an EPA list of notified sites." And that "Over the course of time, the status of the site may change ...". This raises considerable questions as to why this assessment has not been completed prior to moving to demolition.

Contaminants are safely capped and buried at present, but once construction begins, there is a risk they will be released. We have asked Council about their intentions for air quality monitoring, stop-work/activity measures and how communication to stakeholders will be handled.

WCC intends to allow sporting activities (such as operation of the netball courts) to continue around the site while excavation and foundation works are underway. To our mind, this is placing our kids at unnecessary risk.

We also have concerns around timing. The North Sydney Pool is still out of action, with extensive construction delays. To close Willoughby Leisure Centre now, just before the summer holidays, leaves the community with limited options to cool off. On a positive note, some locals have successfully used our direct active transport links to Lane Cove Pool.

The timing, it seems, is driven by opportunism rather than need. WCC was successful in obtaining a \$5 million NSW Government grant, with the stipulation that work commence in 2022. In order to be eligible for this grant, the scope of the project had to be increased beyond what was originally scoped in community consultation.

So, we're left with a \$5 million grant for works which were not even part of the original proposal. In exchange we're left with a rushed closure, no answers about how contamination risks will be handled, and our community must go without their pool for an additional summer. We're not convinced it's such a good deal.

Updates from our three Naremburn ward Councillors



Councillor Georgie Roussac

Halt and review the Western Harbour Tunnel and Beaches Link toll road project:

In October Councillors supported my motion to call on the NSW Government not to enter into any further contracts or tenders associated with the project prior to the March 2023 NSW state election. The motion also requested that Council engage with other impacted councils to share knowledge and identify measures needed to safeguard our community and environment.

The incoming government and its cabinet must have the opportunity to review the whole program of works to assess its value and viability.

Willoughby Leisure Centre

Our much loved, but very tired Willoughby Leisure Centre has recently closed for a long overdue renovation. I've been advocating for this upgrade for ten years, and I'm pleased to have received Council support.

The renovation will transform the Willoughby Leisure Centre with three new pools, a new sauna and spa, enhanced communal areas and importantly, improved accessibility and sustainability outcomes.

In addition to the modern aquatic facilities, we are upgrading the sports hall that will provide services and expanded programs that are important to our local community.

I appreciate some may be disappointed that it will be close over summer, but unfortunately the pumps we need to operate the pool are very much at the end of their life. If we were to attempt to repair them, we would've been closed for much of summer anyway and lost \$5m in funding for our sports hall. The timing isn't perfect, but I'm confident we'll all be really pleased with the finished result.



Councillor Anna Greco

Naremburn has voiced to Council their desire to see the reinstating of its previous advisory committees. However, on 19 September 2022, Willoughby City Council resolved to propose a new structure consisting of four committees. The previous 13 Committees can form part of the proposed new structure.

The role of Advisory Committees, in my opinion, is for Council to draw from the expertise of our diverse, highly educated and engaged community. Committee members volunteer their skills for the benefit of our City of Willoughby.

Unfortunately, our community including members of the previous advisory committees have expressed concern regarding the new committee structure. They have outlined its limitations and noted the proposed structure fails to address any material benefits over reinstating previous committees for this short term of Council.

I would like to take this opportunity to express my sincere gratitude for those previous committee members who continue to offer their skills, expertise and advice and have responded to the Advisory Committee "Have Your Say". The results of the Advisory Committee public exhibition will be presented to Council on 12 December 2022, and the Advisory Committee's future then decided.



Mayor's report

An update from Willoughby Mayor Tanya Taylor

Thank you as always for allowing me the opportunity to update you on a few things that are happening at Council.

Willoughby Leisure Centre

At our 31 October meeting, Council accepted a tender to redevelop the Willoughby Leisure Centre into a stunning new multi-sports complex, delivering new and upgraded facilities for swimming, netball, basketball, volleyball, badminton and one of our newest sports, pickleball.

We'll be closing the pool hall on 19 November to allow the redevelopment process to commence.

We need to begin this work during summer, as the complex's water pump and filtration system has reached the end of its useful life. It is also the case that we need to begin construction before the end of December to take advantage of a \$5 million NSW Government grant.

It is intended that the gym, including group fitness classes, and the school holiday program, will remain open across the entire construction phase The Centre's indoor courts and crèche will remain open from 19 November but will need to close at some stage during the construction period.

By mid-2024, we hope to be opening a new facility that will represent the very best in modern leisure centres.

Henry Lawson's Cave

Also at the 31 October meeting, Council resolved to provide protection to Henry Lawson's cave in Naremburn. We've committed to refuse to give landowner's consent for any application which may damage this cave, and will be calling on the NSW Government to do the same.

We've also agreed that the cave and its immediate surroundings be included in the next round of local heritage investigations. This is an important historical site in Willoughby and deserves to be protected and celebrated.

Beaches Link

We also called on the NSW Government to not sign any further contracts or tenders associated with the Western Harbour Tunnel and Beaches Link toll road projects, prior to the March 2023 election.

I have written to the NSW Opposition seeking its commitment that, if elected, it will halt and review the Western Harbour Tunnel toll road and terminate the Beaches Link toll road project.

Council's position remains the same – we do not accept the Beaches Link Tunnel in its current form.

Advisory Committees

I'm looking forward to receiving feedback on the proposed new structure and policy for our Advisory Committees, which establishes four committees closely aligned to our updated Community Strategic Plan priorities. We're keen to strengthen our Advisory Committees to make them work better for both committee members and council.

Federation of Willoughby Progress Association update



Warringah Freeway

The Federation of Willoughby Progress Association has commenced lobbying on the Warringah

Freeway project. For the community the changes are enormous and certainly a source of local rat runs and local street safety issues. The Department of Roads has essentially moved what it considers a safety issue in its domain to Willoughby Councils local streets. The FWPA has made its comments known to the local State Member Tim James. He is the one left with the issue when it is others before him that let the issue reach a calamitous point of no return without apparent intervention.

At present all local traffic arrives on to the freeway where it sorts out what direction is needed to get to its intended exit, Sydney CBD, airport, Eastern suburbs etc.

If one uses Willoughby Road, Brook Street, or Miller Street from Eastern Valley Way, a driver can sort their direction when on the Freeway. This is going to cease. Transport for NSW thinks the current circumstance is unsafe. (One must query the number of traffic accident reports!).

Following the proposed works, travelling south a driver will need to be on Willoughby Road to get into Sydney CBD. There is currently no other approach lane.

If a person in Naremburn or Northbridge wants to go CBD Sydney, what do they do? They must get on to Willoughby Rd, already at capacity in peak hour. Already cross-city traffic in Willoughby is a traffic bottle-neck (east to west does not work due to the north to south priority in peak hour).

The Warringah Freeway works is a recipe for local rat run and traffic chaos. It would be good for Transport for NSW to explain why this analysis is defective.

It's time to reassess housing numbers



New developments in St Leonards

The Greater Sydney Commission was established in 2018 to plan for 'Growing Sydney', and a significant part of that planning was to set targets on the number of new and types of housing in different districts by 2036.

Naremburn, in the Northern District, is affected by targets set in the subsequent Crows Nest / St. Leonards Plan >2036 (6,683 new dwellings), part of three Local Government Areas and the WCC Willoughby Planning Strategy >2036 (6,758 additional dwellings).

The Special Infrastructure Contribution by developers was part of the State Government plan so that infrastructure "happens in tandem with development" (NSW Government Proposed Special Infrastructure Contribution October 2018).

It's time now in 2022/23 that these two issues of dwelling numbers and infrastructure are assessed to give an indication of how developments are occurring in relation to the State quotas. Current reporting on Development Applications (DAs) by Councils every quarter does not account for the number of dwellings and cumulative numbers against the quota to 2036.

At our October Naremburn Progress Association meeting there was discussion about growth and the effect it had on community amenity. Concerns were raised about the need for space to enjoy active and passive recreation. Protection of Flat Rock Gully was crucial. Without any real time data about housing numbers and associated infrastructure, residents are left wondering if all the development is happening in a 10 year timeframe and not 20!

In April this year The Greater Sydney Commission changed to The Greater Cities Commission (GCC). The Greater Sydney Region has expanded to become the 'Six Cities Region' and we now live in the Eastern Harbour City! The focus has changed. The GCC is working with Councils to develop 6-10 year housing targets. How do these targets relate to the plans to 2036?

Our community would benefit from some time out for a review of the State Planning decisions of 2016-2020 in regard to residential growth, commercial developments, open space and infrastructure. The vision for St. Leonards in the Crows Nest / St. Leonards Plan (finalised in 2020) is that it will be "a jobs powerhouse". Where that vision fits today is a timely question when how and where we work has changed, with the resultant focus on community amenity.

Home break-ins always surge over the holidays. Follow these tips from Naremburn Neighbourhood Watch to stop crime during the holidays.

1. Lock your car and keep the remote for your garage out of your car.

North Shore Police have reported a recent increase in thefts from cars in our neighbourhood. If your garage remote is in the car the thieves can also access your property to steal belongings and often the car keys to steal the car itself. This is a multi-level Christmas gift to criminals.

2. Keep your front door locked and accessible windows closed.

Even when you are at home you need to be aware of the security of your property and yourself. If you are going away, double-check everything is locked.

3. Empty your mailbox

A full mailbox is a signal you're not home. If you're going to be away, ask a neighbour to empty your mailbox and do the same for them if they are away. Or redirect your mail.

4. Keep your plans quiet

Consider toning down the holiday chat on social media. The savvy thieves can use this info to plan their break-in.

5. Get to know your neighbours

Just say hello and once you have a bit of a relationship they can keep an eye on your property when you're not there, maybe take in mail or parcels and help in an emergency. Some people are lonely during the festive season – maybe make an effort to have a Christmas chat.




Love and Virtue by Diana Reid

Summer lovin' for your garden

The Naremburn Community Gardens team has great advice for health, happy summer gardens

Planning to care for your garden in summer really starts before you plant anything. Of course if you already have a garden, you can adopt one or more of these tips to care for your plants in the heat:

- Take note of the number of hours of sun your garden receives each day and buy plants according to this - if your garden gets a lot of summer sun you'll need plants that can tolerate this. Your local nursery can help here or you can get in touch with us.
- Choose plants that are dry summerfriendly or drought resistant. Australian natives are becoming increasingly easier to source (Indigigrow and two favourite suppliers of natives. If you're looking for a fun edible native to try, native oregano is our current favourite. You can source it from Indigigrow and it is easy to grow for beginners.
- Use a wicking bed system. Wicking beds don't require watering as regularly as a conventional garden bed or planter box, as the plants draw water up from a water reserve under the soil, so they're ideal for hot weather.
- Mulch using dried leaves atop the soil of your plants to stop soil getting hot or drying out. You can easily collect freemulch from leaves blown into your garden or collected from a walk.



Cammeray Park and Tunnel Update

Hundreds of residents gather to demand action

On 7 September 2022 hundreds of local residents converged on Green Park, Cammeray to demand action from the government over destruction at Cammeray Park.

The 136 year old heritage listed park has recently seen the destruction of 750 trees and the permanent destruction of 15,000sq metres of parkland with a further 27,000 sq metres at risk due to early works for the Western Harbour Tunnel.

The meeting, organised by Bay Precinct, was addressed by guest speakers from Willoughby Environmental Protection Association, Stop the Tunnels group and North Sydney Mayor, Zoe Baker.

Residents, including many children, planted over 1,000 "ghost trees" with messages to politicians in a bid to stop further destruction. The overwhelming consensus was that residents demand an immediate halt and reassessment of the Western Harbour Tunnel in light of the very poor business case and the environmental destruction.

A delegation from Bay Precinct, Willoughby Environmental Protection Alliance and Stop the Tunnel visited relevant MPs, including local member Tim James, with a selection of trees and messages as well as a letter outlining why the project must be halted and reassessed.

The outcomes of the meeting with Mr James included commitments:

l) to produce a plan detailing the promised 2:1 replacement of trees and follow up the contamination results

2) to ensure Beaches Link would not be signed off before the March 2023 NSW state election

Both North Sydney and Willoughby councils recently passed a motion calling for the \$22 billion+ program of works to be halted and reassessed. Tim

James was aware of the motions but did not support a total re-assessment.

If the projects proceed we will witness an escalation of destruction up and down the Lower North Shore for many years including destruction at Flat Rock Gully. Let's hope the ghost tree messages & motions are heard and actioned!

IS THE BANK A BETTER OPTION?

Considering how shares and property have performed this year, isn't it safer to just keep my money in the bank? Thanks – Bernie, Crows Nest

Hi Bernie,

When you look back at what's happened this year it's easy to think this way, but ironically, just keeping money in the bank is a risky long-term investment approach.

Why?

- 1. Due to the low rate of return, you're unlikely to produce enough passive income to cover your lifestyle, especially after you stop working
- 2. Inflation. Cash has rarely beaten inflation over the longterm, so just staying in cash due to fear of the unknown is not a good long-term strategy. You will get beaten eventually.

Here are some tips:

- 1. Focus on the long term and diversify
- 2. Be disciplined and don't act irrationally to short term volatility
- 3. Use market declines to your advantage and consider systematic investing, like dollar cost averaging
