## MINUTES OF THE GENERAL MEETING OF 8 NOVEMBER 2007

### 1. OPEN FORUM

- (a) **Bicentennial Reserve Baseball Lights** – residents of Garland Road are concerned about the DA proposing the erection of six light towers for the baseball diamond; 12 objections to the DA have been lodged to date. WCC's Infrastructure Services, Open Space Manager, Julie Whitfield, called a meeting of the 'Bicentennial Reserve and Flat Rock Gully Advisory Group' on 30 October; this Advisory Group includes local Councillors, Progress Association representatives and sporting organisations' representatives; noted that it was at least 10 years since the Advisory Group had met; noted that no affected residents were invited. Howard Townsend and Barry Shaw, residents of Garland Road, in the area that would be most affected by the proposed 8-storey lights, stated that residents want to participate in future site reviews.
- (b) **Small Street, right turn from Willoughby Road south** – Naremburn residents access to Leisure Centre and the Reserve via this intersection; there is a left turn arrow, but no right turn arrow; navigating this turn is hazardous.
- (c) **Footpath at Naremburn Village Shops**. Energy Australia new cabling work has been completed. When are the pavers going to be re-laid?
- (d) **Prepay bus Route 272**: Naremburn Food Store will be selling Prepaid and TravelTen tickets
